Terms & Conditions: A credit card (Visa, MasterCard, American Express or Discover) is required, in advance, to insure any incidentals and outstanding balances/payments.

Christina Rodriguez, herein known as the client, agrees to pay the total as stated in this contract. A non-refundable deposit/payment of **\$600.00** is due in order to reserve the SPArty date and time of **June 9, 2007 at 6:00pm**. This deposit/payment reserves only the minimum amount of staff required for the ticket(s) the client purchased, or 1 technician for every 4 hours of SERVICE reserved (not total SPArty time.) Additional staff can not be guaranteed if not purchased in advance. Additional tickets or services added to this client's event will be represented and honored by a receipt of purchase/invoice.

The client is responsible for payment on the balance due in this contract, plus any additions of guests, services or time reserved, regardless of withdrawals, no shows, cancellations, or early endings by they or their guests at any time after paying the deposit and agreeing to and/or signing this contract. Canceling your reserved SPArty at any time or failing to show will result in a complete charge for the entire event, in full, to the client's credit card. If event date or time needs to be changed or altered for any reason, then the paid funds may be credited towards the new date if the change is made more than 30 days out from the originally scheduled event, without any surcharge. Changing, postponing, or canceling your event within 30 days of its scheduled date will result in a surcharge of an additional **25% of your total SPArty or a minimum of \$250**, whichever is greater, and will automatically be charged to the credit card on record.

Final headcount and names, with services, are due no later than 5/09/07.

\$100 NYC Fee, headcount, and final payment of **\$400.00**, to equal the \$1000.00 minimum for the complete SPArty Set-up requirement, **plus any additional services, technicians or time that is requested or needed in order to service the client and/or their guests/event**, will be automatically charged to the credit card on record on **May 9, 2007** unless other payment method options are designated in writing. If other payment option is not received on or before the due date, then the credit card on record will be automatically charged for the outstanding balance.

If minimum \$1000 minimum per SPArty event is not met and paid for, in full, by the final headcount date, then the client's event will be downgraded to include just the spa services and the complete SPArty Setup will be omitted from the client's event.

SPArties will not guarantee that all amenity services will be provided for clients who do not meet this deadline, provide final payment, and/or submit the required information/material requested from SPArties by client for SPArty Setup. Material received after deadline is subject to additional rush fees to the client.

Any overage of staff/technicians or time at event will be billed at the rate of **\$100** per staff-tech/per hour for SPArty Staff, including the full hour's time lapsing into each additional hour to hour time slot, OR the price of the additional service or package that is ordered by each guest, and is due payable, in full, on the day of the event and will be charged to the credit card on record, if not paid by cash or other guest credit card (No checks.) SPArties does not prorate time.

SPArties accepts MasterCard, Visa, American Express, Discover and bank debit cards. SPArties does not accept personal checks unless they are received in our office by 2 weeks prior to event. A \$35 fee will be charged for any returned checks.


Final payment of SPArty packages, a la carte services, or unreturned SPArty items or property becomes the responsibility of the client for any guest. SPArties is not liable for any personal items lost, stolen, misplaced or damaged by the client or their guests.

CONTRAINDICATIONS: There are some medical conditions that are not compatible with spa treatments - serious cardiac conditions and blood clots; skin disease, wounds, or tumors; cancer and tuberculosis; fever, and fractures or dislocations. **Clients who are pregnant or who are under the supervision of a medical professional and/or suffer from a chronic illness or medical condition require written permission from their medical and/or general practitioner to allow them to receive SPArties services.** SPArties has the right to refuse service to any guests with medical conditions not compatible with spa services. Guests should consult with their physician regarding any medical concerns prior to their spa services.

***General Liability and release information:** By consenting to agree to spa services, use of decor, and any potential hazards associated with use of SPArties services and products, this client and their guests hereby release from any and all liability whatsoever, hold harmless and indemnify SPArties Mobile Spa Parties/JRo Consulting and any and all individuals, organizations, and/or organizations connected with SPArties.
